#### Who is the controller of your personal data?

mBank S.A. with its registered office in Warsaw, ul. Prosta 18, hereinafter referred to as the "Bank", is the controller of your personal data.

#### What personal data do we process?

We process the following categories of personal data of our potential corporate clients or contact persons of our potential corporate clients:

- name and surname,
- sex,
- · citizenship,
- phone number,
- e-mail address,
- · job position held at the corporate client,
- address, PESEL, NIP, REGON, type, number and series of identity document of the corporate client refers to a sole trader,
- · name of company,
- · address of company.

#### Why do we process personal data?

We process your personal data in order to establish business relations and provide you with marketing materials promoting services and products of the Bank and subsidiaries of the Bank's Group. The list of mBank Group's subsidiaries is available on the website of mBank Group at: <a href="https://www.mbank.pl">www.mbank.pl</a>. We process your personal data based on legitimate interests of Bank.

### To whom may we transfer your personal data?

We may transfer your personal data to entities that we entrust with providing services (e.g. IT companies).

## How do we obtain your personal data?

We obtain your personal data directly from you or from other controllers, or from publicly available data bases, e.g. the Central Registration and Information on Business (CEIDG).

## How long do we process your personal data?

Personal data are processed for the period of 10 years starting from the date on which they were obtained. Retention periods for personal data of our corporate clients or contact persons of our corporate clients are indicated in the documentation of banking products.

# What are your rights under GDPR?

Under GDRP you have:

1/ the right to access your personal data,

2/ the right to rectification of your personal data,

3/ the right to restriction of processing of your personal data,

4/ the right to data portability,

 $\ensuremath{\mathrm{5}}\xspace$  the right to object to the processing of your personal data,

6/ the right to erasure of your personal data.

In order to exercise your rights, you should send a reply e-mail requesting the bank to do so.
